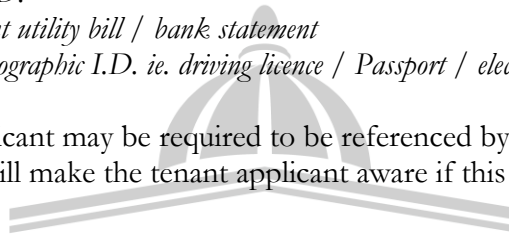
A NORTHERN IRELAND HOME OWNER GUARANTOR MUST PROVIDE:

- Proof of home ownership & I.D.
 - Copy of recent rates bill / home insurance certificate / mortgage statement
 - Copy of photographic I.D. ie. driving licence / Passport / electoral I.D. card

A NON N.I. HOME OWNER MUST PROVIDE:

- Proof of address & I.D.
 - Copy of recent utility bill / bank statement
 - Copy of photographic I.D. ie. driving licence / Passport / electoral I.D. card

NOTE: A Guarantor applicant may be required to be referenced by Home Let along with the tenant applicant, and we will make the tenant applicant aware if this is required.

Whereby it is agreed by these parties that:-

IN CONSIDERATION OF the Landlord agreeing to the request of the Guarantor to grant a tenancy to “the Tenant” of the rental premises formerly mentioned in this agreement.

“The Premises”

1. The Guarantor hereby agrees to compensate fully and indemnify the Landlord for any loss, damage, costs or other expenses arising either directly or indirectly from any breach of the Tenant’s obligations in any tenancy agreement, extension, continuation or subsequent tenancy agreement agreed between the Landlord and the Tenant relating to the premises.
2. This guarantee is irrevocable without the express written consent of the Landlord or any person acting as agent for the Landlord and shall continue beyond the death of the

Guarantor or bankruptcy and is not limited to any fixed term as may be described in any tenancy agreement as may be entered into between the Landlord and the Tenant. The guarantee will continue until such time as the Tenant offers surrender of the tenancy and that offer is formally accepted in writing by the Landlord or any person acting as agent for the Landlord.

- 3. In the event of any breach of the Tenant’s obligations in any tenancy agreement, then upon written demand the Guarantor will pay the Landlord all losses, claims, liabilities, cost and expenses arising out of or in connection with the breach on a full indemnity basis.
- 4. By entering into this Guarantee as a Deed the Guarantor accepts joint and several liability with the Tenant. This means that each will be responsible for complying with the Tenant’s obligations under this agreement both individually and collectively. The Landlord may elect to enforce these obligations and claim damages against the Tenant, the Guarantor or both of them under this clause. These obligations will not be discharged or waived by any act, neglect or leniency or granting of any extension of time by the Landlord in attempts to obtain payment or in enforcement of the Tenant’s covenants.
